## **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 17 MAY 2021**

Reference is made to the circular of Evergreen Products Group Limited (the “**Company**”) dated 9 April 2021 (the “**Circular**”). Unless the context otherwise requires, terms used in this announcement shall have the same meanings as defined in the Circular.

The board of directors of the Company (the “**Board**”) is pleased to announce the voting results of the annual general meeting of the Company (the “**AGM**”) held on Monday, 17 May 2021. All the resolutions proposed at the AGM were taken by poll. The Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the total number of issued Shares was 686,082,000, which represented the total number of Shares entitling the holders to attend and vote for or against all the resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour as set out in Rule 13.40 of the Listing Rules, and no Shareholders were required under the Listing Rules to abstain from voting at the AGM. No Shareholders have indicated in the Circular that they intend to vote against or to abstain from voting on any of the proposed resolutions at the AGM.
